## SENATOR LIBOUS SPONSORS "MARK'S LAW"

On January 30, 2009, EMT Mark Davis of the Cape Vincent Volunteer Fire Department, along with two other volunteers, responded to a chest pain call. The EMTs assisted Christopher Burke who became agitated during the med call, went into his bedroom and came out with a high powered rifle. The EMTS immediately retreated from the residence, but Burke fired two shots, one which struck and killed EMT Mark Davis.



Senator Thoms Libous has introduced legislation named after Mark Davis. "Mark's Law" (S.4717) will provide for the strongest penalty allowed under New York State law-life imprisonment without the possibility of parole - to anyone convicted of murdering a "volunteer firefighter, EMT, nurse, doctor or any other volunteer in the line of duty".
