Broome County Director of Emergency Service Jerry Marinich and Broome County Executive Debra Preston were also on hand as awards and 50 year pins were handed out to the honorees.

**ROBERT BURROWS:** Robert Burrows joined the Ouaquaga Fire Company back in 1953. During his 63 years he has served as chief, assistant chief, lieutenant and captain. He was also Fire District Treasurer for 50 years. Bob is still actively involved in the fire company, currently serving as Assistant Treasurer.

**GREGG COOK**: Gregg has been a member of Endwell/O. L. Davis Fire Company since 1965. Gregg has served in many positions including Assistant Chief and he is currently a fire company trustee. After 51 years he remains very active with the fire company and is still an interior firefighter. In 2015 he volunteered over 800 hours for calls, trainings and other fire department work. Gregg also serves as the Broome County haz mat captain.
