



Training Announcement: **Swift Water/Flood Rescue - In-Service/Refresher**

State Preparedness Training Center

Course Description

A 24-hour Swiftwater/Flood rescue skill refresher training for Swiftwater/Flood rescue technicians. Course includes basic skill refresher for moving water and/or flood conditions including: river search techniques, water rescue equipment, swift water rescue techniques, boat-based rescue techniques, and Rescue Swimmer rescue techniques. Course includes hands on training sessions in both surface water and swift-water environments. Course meets NFPA 1006 standards for Surface, Swift water, and Flood Rescue on going.

Prerequisite: Swiftwater/Flood Rescue Technician
